General Proposal on Clearing between Highway 17 to the water from Toney and Dustin Gaskins. Approximately \$ 25,000.00. The Clerk has reviewed the Budget AND: The only line item that would support the expenditure is Street Maintenance. That Budget amount is \$92,273.00 and \$ 15,143.12 has been allocated and spent. Clerk is not sure (as of the date of this agenda) if there is another expenditure expected for this line item or not. Commissioner Tyndall and Mayor Chittick, we will need to meet to discuss previous uses of this Line Item.

Your Town Clerk is surprised to learn that there are three more weeks of Clerk Certification training included in this tuition. I will advise of the future dates as they are confirmed.

I have been in contact with Terri, Town Clerk of Pollocksville. They use a company called Invoice Cloud for their credit card paying customers. There is a fee of 3.95 that is charged to the customer, not the town. We are in contact with the software company, FMS, regarding the implementation of the Invoice Cloud and what that process will involve.

Mr. Freddie's Utility trailer has been diagnosed, and the repair quote came to \$ 2295.13. This would come out of the Streets Maintenance Budget.
